#### The intended use of the product/-s:

The product can be used as a Single Patient Use sliding material for users who need friction reduced during transfers. Recyclable plastic.

#### **Correct use of the product:**

Super Glide ECO Open can be used during transfers from e.g. wheelchair to bed, on operating tables, in bed and during other transfers where the user needs help due to high friction from the surface.

#### **Contraindications:**

As the material is made of plastic and is therefore not breathable, The product should not be left under the user for a long time, as this can cause damage to the tissue. Always use the product in double layers to achieve optimal friction reduction.

#### Warning:

Never leave the user on the product when lying on the edge of the bed since this poses a risk of the user falling to the floor. Do not leave the product on the floor due to risk of falling.

#### **Risk assessment:**

Always make a risk assessment and a functional assessment of the user prior to using the product. This way using the product for transferring or moving a user, is ergonomic and legally sound.

#### Knowledge of the product/transferring:

It is important that the user of the product has been properly instructed in the use of the product and has read the user manual thoroughly prior to using the product.

#### **Turning to sidelying using Super Glide ECO:**



1. Bend the user's legs (Super Glide ECO can be used here) and turn user slightly to one side. Place the Super Glide ECO with the fold close to the user's spine or under the draw sheet at the side you wish to turn the user towards.



2. Turn the user to supine. Place the user's arms on the stomach or the pillow. Turn the user to the opposite side and slide the user to the perfect position using the Super Glide ECO.



3. Remove the Super Glide ECO by pulling the lower part from one corner. If you feel resistance pull the opposite lower corner. You can also pull the fold in between the sides and let the Super Glide ECO slide on itself.

#### **Higher up in bed – Dependant user, one helper:**



4. Place the hand in the Super Glide ECO fold. From the top slide the Super Glide under the user's shoulders - begin on one side and continue the same way on the other side.



5. Elevate the bed end to use the gravity. Bend the user's legs, fixate the feet and ask the user to push the upper body upwards. Alternatively place the Super Glide ECO under the sheet and use this as a draw sheet.



6. Super Glide ECO glides under the user's shoulders and the user can easily slide upwards in bed with reduced friction. Remove the Super Glide ECO by pulling the lower part from one corner. If you feel resistance pull the opposite lower corner.

#### **Sideways transfer with Super Glide ECO – Two helpers:**



7. Turn the user to side lying. Helper A places the folded Super Glide ECO with the fold close to the spine. To achieve comfort and perfect working conditions a draw sheet could also be placed over the Super Glide ECO.



8. Return the user to supine lying. Helper B pushes the user to the side and Helper A pulls the draw sheet. The Super Glide ECO reduces friction enormously during the transfer.



9. Remove the Super Glide ECO by pulling the lower part of the Super Glide ECO. You can also pull the fold in between the sides and let the ECO slide on itself.

#### Transfer between bed and chair:



10. Ask the user to lean to the opposite side. Place the Super Glide ECO — Open under the user's lifted buttocks.



11. Place the Master Glide under the folded Super Glide ECO, to build the bridge and make the transfer easier. Remember to make use of the user's resources during the transfer.



12. Make the transfer. Remove the sliding board. Pull the lower part of the Super Glide ECO to get it out.

#### Turning with Super Glide ECO, Multi Sheet, and a hoist:



13. Mount the Multi Sheet on the hoist. Turn the user slightly to one side. Place the folded Super Glide ECO Open close to the spine. Make sure to place it under the pressure points of the head, shoulder, and buttocks.



14. Mount the Multi Sheet on the opposite side to the hoist. Lift up, slide, and place the user in a perfect position using the Super Glide ECO. Thus reducing friction between the sheet and the Multi Sheet.



15. Grab a corner of the lower part of the Super Glide ECO and pull it out. If resistance is felt grab the opposite lower corner instead and pull here.
